

# Manka's Meadow — Privacy Policy

Manka's Meadow ("Manka's Meadow," "we," "our," or "us") respects your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, share, and safeguard information when you visit **mankasmeadow.com** or use any online services that link to this Policy (collectively, the "Website").

By accessing or using the Website, you agree to this Privacy Policy.

## 1. Information We Collect

We collect personal information in two ways:

- (1) information you voluntarily provide, and
  - (2) information collected automatically when using the Website.
- 

### A. Information You Provide

When you contact us through the Website—such as using an inquiry form, email link, or reservation interest form—you may voluntarily provide:

- Name
- Email address
- Phone number (optional)
- Message content or project/event inquiry details
- Any additional information you include in your message

This information is used **only to respond to your inquiry or request**. We **do not** use this information for advertising or retargeting.

We do **not** sell or share your information with marketers.

## B. Information Automatically Collected

We collect standard analytics and technical data when you visit the Website, such as:

- IP address (anonymized or truncated where possible)
- Browser type, device type, and operating system
- Pages viewed and time spent on the site
- Referring website or search terms
- Click behavior and navigation patterns

This information is collected through **first-party cookies** and basic, privacy-focused analytics tools.

We do **not** use:

- Advertising cookies
  - Retargeting pixels
  - Cross-site tracking tools

## 2. How We Use Your Information

We use collected information for the following purposes:

### A. To Communicate With You

- Respond to your questions or inquiries
- Provide information about private events, amenities, or offerings
- Follow up on reservation interest
- Offer support regarding your visit

### B. To Improve the Website

- Analyze page performance and visitor interactions
- Maintain Website reliability and functionality
- Monitor security and prevent misuse
- Improve user experience

### C. For Legal or Security Purposes

- Comply with applicable laws
- Protect against fraud or malicious activity
- Maintain business records and operational logs

We **do not** use personal information for advertising, profiling, or automated decision-making.

---

## 3. How We Share Information

We may share your information only under the following limited circumstances:

### A. Service Providers

We may provide information to trusted third-party vendors that help us operate the Website, such as:

- Hosting providers
- Site security or technical support vendors
- Analytics providers (with privacy-centric configurations)
- Email or communication platforms

These companies may access information solely to provide contracted services. They are **prohibited** from selling, sharing, or using your information for advertising.

---

### B. Legal Requirements

We may disclose information where required to:

- Comply with federal, state, or local laws
  - Respond to lawful government or regulatory requests
  - Protect the safety, rights, or property of Manka's Meadow, our users, or others
- 

### C. Business Transfers

If Manka's Meadow or its related businesses undergo a merger, acquisition, or restructuring, personal information may be transferred under appropriate confidentiality protections.

## 4. Cookies & Tracking Technologies

We use **minimal, first-party cookies** for:

- Website functionality
- Security and performance
- Basic usage analytics

We do **not** use cookies or trackers for:

- Advertising
- Behavioral targeting
- Cross-site user profiling

You may disable cookies through your browser settings, though some Website functions may be affected.

## 5. Data Retention

We retain personal information only as long as necessary to:

- Respond to inquiries or requests
- Support business operations
- Comply with legal obligations

When no longer needed, data is securely deleted or anonymized.

---

## 6. Your Rights (California & U.S. Privacy Laws)

If you are a California resident, you have rights under the **California Consumer Privacy Act (CCPA)**, as amended by the CPRA, including:

### Right to Know

Request details about:

- Personal information collected
- Sources of information
- Purpose of collection
- Categories of third parties (if any) to whom information is disclosed

### Right to Delete

Request deletion of your personal information, subject to applicable exceptions.

### **Right to Correct**

Request correction of inaccurate data.

### **Right to Opt Out of Sale/Sharing**

We do **not** sell or share personal information for advertising.  
No opt-out mechanism is required but you retain the right to request.

### **Right to Limit Use of Sensitive Personal Information**

We do not collect or use sensitive personal information.

### **Right to Non-Discrimination**

Exercising your rights will not result in discriminatory treatment.
